- If you have indicated that you will require power, please supply your own electrical leads and any other equipment required for your Stall. Electrical equipment must be in accordance with Relevant Australian Standards.
- Photographs and video taken during the Event by Nan Tien Temple (NTT) certified photographer may be used by NTT for promotional or archival purposes. By submitting this Expression of Interest, you agree to allow NTT to publish your image and name in various media avenues including television, newspaper and social media.

T&C's for Workshop Applicants

- If approved, you will set up and pack up by the times agreed upon between yourself and Nan Tien Temple.
- The earliest your site can be set up is 8:30am and must be cleared by 5.00pm at the latest.
- During trading times, you are responsible for ensuring your space is attended, presentable, professional and safe.
- Please remove your waste at the end of the day.
- Please remove all vehicles off site after unloading and all vehicles must be parked in the main car park or off site before starting your workshop.
- If required, you must be able to provide your own 3x3m marquee, tables and chairs.
